Narr: Original Narrative - F3320 Sgt Jeremy W Durst 4/03/2020

On 4-3-20 at approximately 1930 hours Akil Prentice called into police headquarters to advise he and his roommate (Aaron Francis Curtis) each had a television stolen from their residence at 121 Wood Street. At this time I (Sgt. Durst) spoke to Prentice.

Prentice advised that sometime between 3-28-20 and today (4-3-20) someone unknown entered into his residence and removed two television sets. Prentice advised there were no signs of forced entry into the residence. Prentice advised when he arrived today at 1900 hours he did find the front door unlocked. Upon checking the residence he observed a blind had been pulled back on a window and he believed the window was unsecured and that was how the suspect(s) made entry into the residence. Prentice advised there was damage to two different interior doors and a hole in a wall. Upon checking the residence Prentice advised the only two items he noticed missing were as follows:

1. Black in color 32 or 36 inch Vizio Flatscreen TV (no other identifiable)
2. Black in color 50 inch Flatscreen TV belonging to Curtis (no other identifiable)

I advised Prentice if he located any other items missing, he could send me an email and I would add them to my report. I further advised Prentice to try and find the approximate values of the televisions stolen as well as serial numbers. Prentice advised he would check on that information.

Prentice further advised he would send pictures of the damage to the interior doors and wall to my email so I could attach them to the report as well. Prentice read my email address back to me and I verified he had written it down correctly.
