### Some bullet points to share with you:

- We have approximately 70 students living in our resident halls including Edgewood Commons. The plan is to
  move all residential students to Edgewood Commons which is a P3 arrangement with Medco and its own staff
  once we get our traditional residence halls emptied. Edgewood commons is apt-style living with separate
  bathrooms and kitchens. That way we consolidate all of our students in one residence hall that is privately
  managed and has better facilities.
- We had just over 1000 students who lived on campus. Over 2/3 have moved out or signed up for a move-out time. The process is following healthcare guidelines and similar to what other USM schools are doing. We started a bit earlier than some other schools this past Monday.
- Now that we have seen the demand for facilities from students on campus or in town, we are beginning to scale
  back facilities on campus. We will be using Gira CCIT for computer lab space and some study space (will likely
  not be a big need once students are in Edgewood commons). Library access will soon be completely online.
- Food services are being provided by Chartwells on an order and pick-up plan. Less than 100 students are still
  using their food plans. Chartwells is also offering food for staff on campus.
- We are developing refund plans for room and board and some fees. I was disappointed that some in the
  community and on campus were attributing the delay to the assumption we were trying to keep the money at the
  students' expense. In fact, the decisions on 1) going to online for the rest of the semester and 2) provide pro-rated
  refunds were being made at the system level after consultation with the regents. We expect the refunds for FSU to
  be somewhere in the range of \$5 million, if not more.
- We have curtailed employees on campus to one of the lowest in the system (even though there still seems to be some in the community who have complained about too many on campus). At this point, less than 10% (and I suspect it is closer to 5% are on campus during the day) of the employees are expected to be on campus. These include police, healthcare (although all counseling provided through WMHS is now online), physical plant, and IT support.
- We have several hundred students working online that are still working in the community or state. That includes
  several hundred RNs who are in our online program and we are making accommodations for those who find their
  studies slipping because of work requirements. And, we have student teachers that are staying home but we are
  working with school districts to see how they might help regular teachers with online instruction.
- At this point, construction on the new residence hall continues. We are supposed to receive furniture from MD corrections in late May. The Education & Health Sciences building is supposed to go to DPW at the beginning of April and bid packages will go out shortly thereafter. Some of the infrastructure work on the new building has been bid and will begin immediately after DPW approval. As long as the governor permits construction work to continue, our contractors will continue.

• Lastly, to this point, we have had no issues with students off-campus who may have returned to the community. They seem to be respecting social distancing and social gathering guidelines. I continue to update county and city leadership about what is happening at FSU.
